- (1) Each time vesting restricted stock units (each, a "TVRSU") represents a contingent right to receive one share of common stock, \$0.01 par value (the "Common Stock"), of Mack-Cali Realty Corporation (the "Company").
- (2) The TVRSUs vest in three equal annual installments beginning April 21, 2022.

- (3) Each performance vesting restricted stock units (each, a "PVRSU") represents a contingent right to receive one share of Common Stock.
- Seventy-five percent (75%) of the PVRSUs may vest over a three year period based on the attainment of absolute total stockholder return ("TSR") metrics by the Company (4) over a three year performance period. The remaining twenty-five percent (25%) of the PVRSUs may vest over a three year period based on the Company's TSR relative to the TSR of a select group of twenty-four (24) peer REITs over the same three year performance period.
